## 4. LEGAL AND BINDING AGREEMENT

# 5. ARTIST SCOPE OF WORK/RESPONSIBILITIES

Beginning with the Effective Date of this Agreement, the Client allows the Artist to perform the following hair and/or makeup services. The services will include:

- Initial consultation to determine Client's desired look for the wedding
- Trial hair and/or makeup prior to the wedding, if booked (recommended)
- Applying hair and/or makeup for the Client(s) to the Client's satisfaction, but not to exceed the allotted time detailed in Section 2.

## 6. CLIENT RESPONSIBILITIES

The Client agrees to communicate in a timely manner with the Artist and to provide all necessary information to enable the Artist to perform the hair and makeup services.

The Client also agrees to notify the Artist prior to the wedding of any hair or makeup product allergies, skin conditions, or sensitivities of all persons receiving services.

The Client understands that they are responsible to pay all Artist and/or Assistance fees, Travel, Parking, Deposits, and/or Hair Extension fees, in full.

The Client agrees to contact the Artist in writing prior to making any changes to the wedding date, time and scope. The Client understands that the Artist will make their best efforts to accommodate such changes, but may not be able to accommodate all changes.

The Client is responsible for providing the Artist with an adequate environment to perform the hair and makeup services. This includes sufficient outlets, tables and low chairs.

# 7. OVERTIME/ADDITIONAL CHARGES

Delays:

For Client delays, MMW is not responsible if client(s) are late. To avoid any delay in services, please plan accordingly. To ensure all persons are ready for their makeup appointment, please arrive 15 minutes prior to the scheduled time. **No wet hair please!**

## TRAVEL AND PARKING:

Additional fees will be assessed if the hair and makeup artist is required to travel to the wedding, including but not limited to flights, hotel accommodations, and transportation. Travel to events within <u>40</u> miles of <u>Artist Home</u> is included free of charge. For events outside this area, an additional mileage fee of <u>\$50</u> per hour per Artist, each way, will be assessed.

If the event location requires parking fees for the hair and makeup artist and staff, these fees will be added to the total bill for the service.

## EXTRA HAIR AND MAKEUP ARTIST:

For larger parties, an additional hair and/or makeup artist may be required. An additional artist requires a fee of \$<u>300</u>. An Assistant Artist requires a fee of \$<u>200</u>.

## 8. TRIAL HAIR AND MAKEUP APPLICATION

A **"trial run"** of the hair and/or makeup application is recommended to be booked prior to the wedding. 50% of the trial fee \$\_\_\_\_\_ must be pre-paid (on website) when services are booked and is non-refundable. An additional <u>\$250</u> will be paid day of trial. Total trial fee: \$\_\_\_\_\_. If an additional trial is needed, a fee of <u>\$200</u> an hour will be charged. #### 9. COMPENSATION

The Parties agree that the total amount of \$\_\_\_\_\_\_ will be paid by the Client to the Artist for the payment of the hair and/or makeup services. A non-refundable deposit is required to book the Artist's services. The Client agrees to pay the remaining balance of the amount of \$\_\_\_\_\_\_ by the day of wedding. If the Client does not complete payment the Artist has the right to not perform the services on the wedding date.

If Hair Extensions are not returned by the Client in full within <u>30</u> days after the wedding date, a late fee of the amount of \$<u>50</u> will be assessed every week until payment is completed. MMW accepts cash, checks, Venmo, and credit cards. A 3% fee will be added to Venmo and credit cards.

#### **10. CANCELLATION**

#### BY CLIENT

If the agreed upon services are canceled for any reason within 60 days of the wedding, the Responsible Party must pay the outstanding balance of \$<u>450</u> to MMW within 10 days of notice of cancelation.

#### **BY ARTIST**

If the unlikely event that the Artist must cancel, MMW will provide a suitable replacement hair and/or makeup artist. No additional charges or refunds will be applied.

## 11. FORCE MAJEURE

Neither party shall be liable for any failure or delay in performance under this Agreement if such failure or delay is caused by an event beyond its reasonable control, including, but not limited to by reason of act of God, fire, flood, earthquake, hurricane, or other natural disaster, malicious injury, strikes, lock-outs, or other labor troubles, riots, insurrection, pandemic, terrorism or other reason of like nature.

# 12. DISPUTE RESOLUTION AND LEGAL FEES

In the unlikely event that a dispute arises from this Agreement and it cannot be resolved between the Parties, the Parties agree to engage in mediation. If the dispute cannot be resolved through mediation and results in legal action, the successful party will be entitled to all their legal fees.

# 13. INDEMNIFICATION AND LIABILITY

The Client agrees to hold the Artist, employees, and agents harmless from and against any and all claims, damages, liabilities, costs or expenses in connection with the services provided by the Artist under this Agreement, except to the extent that such claims, damages, liabilities, costs, or expenses are caused by the gross negligence or willful misconduct of the Artist. The Client is responsible for notifying the Artist of any allergies or sensitivities to hair or makeup products prior to wedding, for all persons receiving the services. The Artist is not responsible for allergic reactions or adverse effects due to any products and tools.

#### 14. SEVERABILITY

In the event any part of this Agreement is deemed invalid or unenforceable, in whole or part, that part shall be severed from the remainder of the Agreement and all other provisions will remain in full force and effect.

#### 15. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the wedding location described in Section 2.

# 16. ENTIRE AGREEMENT

This Agreement contains the entire contract between the parties and supersedes any prior agreements, written or otherwise, between the Parties. Any modification to this contract must be agreed upon in writing by both parties. This Agreement will commence from the Effective date and will continue until the scope of work noted in Section 5 is completed.
